The lead teacher is responsible for staff and student head count.

The T.A.s and Co-Teachers are responsible for managing the behavior of the students, and in absence of a lead teacher, fulfilling the responsibilities of the lead teacher.

All staff certified in First Aid are responsible for tending to the medical needs of the students as necessary.

Program assistants are responsible for communication between classrooms, between administration and classrooms, contacting emergency services, and contacting parents and guardians.

All staff are responsible for the welfare of their students. Staff are required to stay with their students until notified by the director or administrator. Failure to do so may result in termination or possible legal prosecution for child endangerment.

### Completion of High School Graduation Requirements

Students in California public schools must pass both the English-language arts and mathematics portions of the California High School Exit Examination (CAHSEE) to receive a high school diploma.
